Learning Objectives

The information presented at this education activity should improve your ability to: (1) recognize child physical abuse, (2) report to child protective services when concerns are identified, (3) consider the patient and clinician factors that impact recognition of child physical abuse, and (4) utilize the latest guidelines in evaluating children for concerns of child physical abuse.

Participants will be provided with lectures and simulation training in the evaluation of child physical abuse to include interviewing, diagnostic testing, follow-up medical care, and reporting requirements to the Department of Social Services and Law Enforcement agencies.

Participants will demonstrate skills including: conducting a caregiver interview, interpretation of physical exam findings, proper documentation of written reports, and formulation of final conclusions.

Ms. Howison is a Child Protective Services supervisor with Chatham County DSS.

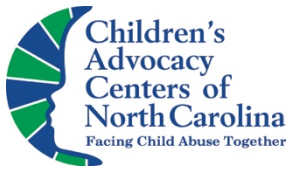
Benny Joyner, MD, MPH
